PRESCRIPTION ASSISTANCE

We understand that prescription medications that we prescribe can be costly, especially since the anticoagulants Xarelto and Eliquis will not be available as a generic until sometime in 2021 (estimated).

Medicare regulations strictly govern our ability to provide sample quantities to our patients. If you are in a situation where your anticoagulation is unaffordable due to a high coinsurance or by being in either a deductible or "donut hole" period, please visit the sites below.

Xarelto (rivaroxaban)

There are several options for savings from the manufacturer of Xarelto. There are options to have a reduced monthly copay for commercially-insured patients, an option to have a one-time 30-day supply as a Medicare or Medicare replacement insured patient, and a program that limits the copay to \$85 monthly with some qualifications. If you call 1-888-XARELTO (1-888-927-3586) they will attempt to qualify you for all of the programs to find the best one to fit your qualifications.
